9. **SUPERINTENDENT'S CONSENT AGENDA**

- (a) Motion to approve the resignation of Jazmin Yadav, Special Pathologist at the end of the 2020-2021 school year. Jazmin has been with the District for 2 years.
- (b) Motion to approve a delegate and an alternate as official representative of the Fredericktown Board of Education to the Ohio School Board Association's Annual Conferences.

- (c) Motion to approve Brian K. Stanford, as the Food Service Consultant for the 2021-2022 school year at \$4,200 per year. No increase from previous year.

- (b) Motion to enter into a 5-year extended contract for Treasurer Heather Darnold for a term commencing on August 1, 2022 and ending on July 31, 2027. The base salary will increase by 2% for year 2022-2023, 2023-2024 and 2024-2025. Years 2025-2026 and 2026-2027 will be renegotiated no later than August 1, 2025 and the salary rate cannot be lower than the rate set for school year 2026.
